I understand that I must be the successful bidder at Sheriff's sale and that if I am NOT the successful bidder at Sheriff's sale I will be refunded my original deposit upon sale to someone else. I attest that property taxes and assessments on ALL properties I own in Ohio are fully paid, and I understand that no property will be transferred to my name as long as I and / or my spouse or business entities have unpaid taxes in Logan County or ANY OTHER COUNTY IN OHIO. I understand I have NO legal right to enter the property, until I have legal possession of the deed. I understand it is my responsibility, prior to submitting an application, to confirm the possibility of demolition of any structures, along with any violations of applicable local codes. I understand that property taxes are charged one year in arrears.
